- There has been extra mowing on the soccer fields. Nets are being damaged.

- GRD Advisory meeting was held this past week. Feasibility study was presented, household registration forms were passed out and the Harvest Festival discussed. Next meeting will be in December prior to the Senior Dinner.
- GRD Night at Football will be Friday, September 23rd. Players wearing their uniforms will get in for free and then announced at half time of the game. We are working on a GRD Night for soccer also.

- Tackle football is going great. The concession stand is open during the games. The GRD parents are working and the funds raised will go to the Athletic Boosters.

- Pet-a-Palooza was last weekend it went well. They left the park very clean.
