NEW BUSINESS:

Rotary Bridge - 4-F Letter:

Township Trustee Jenks submitted a MOU to the GRD concerning the Rotary Bridge project. The Prosecutor wrote the MOU on behalf of the Township, which in turn would like to have signed by the GRD Board of Trustees. The MOU was reviewed by our legal counsel and he shared a number of concerns about the document. Most notably that the document was generally vague and it was not clear what potential obligations the GRD could have pursuant to the document.
