NEW BUSINESS

a. Granville Fellowship Funding

Executive Director, Leigh Ann Miller made a presentation of the 2013 Budget for the Senior Fellowship. She also answered questions from the Trustees and thanked the GRD for their continued support of the Fellowship.

b. RVP Build Out

Chris Lucas-Miller and Eric Albery of Albery Construction presented 2 projects, Batting Cages and Dugouts. Batting Cages Kit would have the nets hanging from the inside and the bases can be set. In the off season the nets can be taken down and stored. Placement would be between Fields 1 and 4. This location was chosen based on flood plain restraints on Field 2 and 3. Proposal is \$13,429.87. Softball dugout proposal is for a change from the existing style. The existing dugouts have some structural issues. In order to complete 4 dugouts before the spring season we would need to extend into the 2013 budget. Correcting problems with the current 4 dugouts would cost more in the long run. It was agreed to move ahead with one batting cage as budgeted.
