PUBLIC COMMENTS

Steve Mendicino and Bob Warner with the wrestling program were present to answer any questions regarding the barrier wall to be constructed at the Granville High School. Current confirmed funding is now \$33,000.00, additional funding is still needed. The lowest construction bid withdrew, the remaining bids are in the \$45,000.00 to \$70,000.00 range. The wall needs to be built this summer. The school is willing to work with the scheduling.

b. Granville Stingrays – GRD Integration

- Melissa Gilbert, on behalf of the Stingrays, has requested to come under the umbrella of the GRD. The 1st parent meeting was held last week. Andy is suggesting that the conversion be one lump sum of registration fees. We then would facilitate the disbursements for the season. Discussion was held.
