Executive Director's Report

NEW BUSINESS

- a. Internal Maintenance Proposal
 - A Powerpoint of the Internal Maintenance Proposal was presented. We have not solved the maintenance issue for GRD yet. This is a big challenge. The last 4 years of maintenance has been looked at closely. Maintenance is a great concern for us moving forward as we are currently setup. The Ventura Brothers are no longer at our disposal at all times for maintenance.
 - Discussion was held around questions and concerns after the presentation. Trustees would like to know the industry standards of mowing time and maintenance of mowers. Concerns were expressed about what a full time person would do in the winter season, do we have enough work to keep them busy? Trustee Barrett asked if it might be better to consider a part-time person for maintenance and continue outsourcing our mowing with Legend Lawn and Landscape our current mowing contractor.
- b. Resolution 2015-05 Payment Authorization Vermont Systems \$11,333.64

Motion was made to authorize payment to Vermont Systems in the amount of \$11,333.64 for 2015 maintenance by Vice-Chairperson Barrett, seconded by Trustee Wolf. Motion passed 5-0.

c. Resolution 2015-06 Payment Authorization – Class Acts \$10,065.00 Motion was made to authorize payment to Class Acts in the amount of \$10,065.00, for the deposit of the Concert on the Green Series by Trustee Klaus, seconded by Trustee Masterson. Motion passed 5-0.

OLD BUSINESS

a. Medical Benefit Package - update

Benefit packages for Aetna Health and inHealth were presented. The shop plan for small business was not recommended. We will get a tax credit for one of these plans. It is Director Wildman's recommendation to go with Aetna Health. Total monthly cost will be 10% for the employee and 33% for the dependents. There will be no dental coverage without a group of 2 people, medical coverage with just a group of 1. Vision package is included. There is no risk to not opting into the plan at the beginning of the year, you can always opt in during the year.

Enrollment beginning February 5th, 2015 would provide coverage March 1st, 2015 for those choosing to participant. Chris Skidmore needs to give 30 days' notice to his current provider.

Trustees would like to have the \$1,107.28 for single family coverage confirmed and how it will impact the budget for the February 5th, 2015 meeting.

Chairperson Koester suggested that we have Craig Predieri create an employee benefit package for GRD. Possibly having him come to the February 5th, 2015 meeting to guide us through the employer process.
