c. Disbursement Approval – Legend Lawn & Landscape \$7,885.00

OLD BUSINESS

- a. Bryn Du Bruce Cramer, Executive Director of Bryn Du , has inquired about the three outstanding invoices for 2014. The invoices were for field rental fees associated with youth sports (field hockey, flag football and lacrosse.) The crux of the challenge is the unsolved mowing quid pro quo created in January 2013 with the Village of Granville. The arrangement was created to serve as an in-kind payment for the rental of office space at village hall. That arrangement in principal changed upon the GRD's move to the GEVS Admin Building from village hall in January 2014. The GRD has been actively pursuing free programming space at Bryn Du in exchange for mowing services. While there has been significant progress in many aspects of the collaboration with Bryn Du and the GRD, the outdoor field rental remains a problem. The Board of Trustees believes that \$13,000 for mowing, and \$3,200 for field rental, is inappropriate and unreasonable. The board has directed Executive Director Wildman not to pay these invoices. To properly explain the Board's position on this issue, Executive Director Wildman has been directed to craft a memo and present it to Village Manager, Steve Stilwell. After further discussion the Board of Trustees is presenting two potential solutions to Village of Granville Council:
 - A.) Invoice Village for \$14,000.00 for mowing expenses incurred at Bryn Du Mansion in 2014. After receipt of payment, the GRD will pay Bryn Du Commission \$3,200 for the unpaid field rentals.
 - B.) Invoice the Village of Granville \$14,000.00, showing a credit of \$3,200 for field usage, bringing the total of invoice due to \$10,800.00.

Motion was made to have Executive Director Wildman present Granville Village Manager Steve Stilwell in person the above two options, the initial lease agreement and GRD Resolution with any other discussion needed to be followed up with Chairperson Koester and Trustee Wolf by Trustee Klaus, seconded by Vice-Chairperson Barrett. Motion passed 5-0.
