## CALL TO ORDER AND PLEDGE OF ALLEGIANCE

#### **ROLL CALL**

#### **PUBLIC COMMENTS**

- Phil Stukus read and presented a petition signed by concerned citizens of the Granville Senior Center. The petition reads "We the undersigned are requesting the Board of the Granville Recreation District to reinstate funding to the Granville Senior Center to \$6000.00 for 2015 and subsequent years. It is our understanding that the GRD Board has decided to cease funding of the Granville Senior Center as of 2016 with funding being at a reduced level for 2015. We note that the mission of the GRD is to develop, manage and coordinate recreational, educational, social, cultural and athletic activities for citizens of all ages within GRD."
- The Senior Center is charging a \$20.00 user fee for the first time this year.
- Phil Stukus suggested that we consider having a senior of the community hold a seat on the GRD Board. Director Wildman explained how the Board of Trustee is made up and that the Village of Granville is looking for a representative right now to fill a vacancy, this would be a three year term.



- Judy Stansbury, a member of the Granville Senior Center attends activities weekly enjoying the fellowship and programming at the Center. The \$6000.00 dollars provides important senior specific programming for the center and its members.
- John Weigand a physician in Granville would like for the board to reconsider pulling funds from the Granville Senior Center.

#### **OLD BUSINESS**

a. Internal Maintenance Proposal Andy presented a list of Retired Equipment that the Village of Granville will be selling in the next 60 days. Three trucks are on the list. The 2001 Chevrolet 1 Ton Dump Truck for \$9500.00 would be a good fit for the GRD. It is equipped with a dump bed for gravel, a plow and a salt spreader. The mileage is low, but they are hard miles with the type of work that is done with this truck.
