a. <u>Resolution 2016-010</u> – Disbursement Approval – Matthews Ford \$13,575.87 Our F350 Diesel 2005 dump truck has been taken to Matthew's Ford. Issues were worse that we thought. John Thacker has looked at the truck and gave Bobby a list of what needs to been done. Due to a tie rod issue it cannot be driven, it is a safety issue. We researched costs and alternatives but this is the best option. GRD will get a 2 year warrantee and \$3000.00 off in exchange for advertising on our website and banners at the fields. Trustee Naille suggests that in order to keep the Matthew's Ford warrantee intact that we continue to have all future work on the dump truck done at Matthew Ford.

Motion to disburse payment to Matthews Ford in the amount of \$13,575.87 for repairs on the F350 Diesel 2005 dump truck by Vice-Chairperson Wolf, seconded by Trustee Goss. Motion passed 4-0.
