- b. Cherry Valley Task Force:
 - The Task Force is a group of citizens appointed by the Village to determine what can be done with land in the Cherry Valley corridor. George Martin owns property behind the Speedway Station and wants to develop it. Initially he took the proposal to the Village for approval but was turned down. He is now revising the plan to add recreation in hopes that the plan will then be approved for development. That is the reason it is on our agenda.
 - Keith Meyers also suggested that a recreation facility could be a possibility.
 - The Cherry Valley task force is asking for input from the GRD about recreation and future facilities in the community.
