Vandalism

There was a lot of information in the paper and on TV about the McPeek Lodge vandalism. Andy will follow up with the Granville Police Department and ask if they are in a position to help monitor the parks and/or lock the gate. Bobby and Andy will look into the cost of security cameras. We know we would have some challenges with installation, lack of Wi-Fi and cost. The missing canoe was found by Granville resident Tim Sawyer and was returned.

Takeaways: Discussion with GPD and investigate cost of security cameras.

Program Fees

Discussion surrounding fee structure was held. Question is about how much a few instructors make per class and should the GRD be getting a larger portion of that class fee to cover Administrative costs. Currently we collect a flat \$20 fee from each registration fee, per class, per participant. Instructors receive the balance of the registration fee and that fluctuates based on the number of participants registered in the class. Therefor the amount the instructor receives can be a large or small. So, should we be collecting a larger percentage of the fee on classes that are more expensive? There are several ways to set up the fee structure. Contractual, Flat (GRD Current), Flat Tiered, Percentage Base.

Takeaways: Andy and Lesa will research a percentage based fee structure.
