- a. GRD Reopen Report

 - New guidelines are coming out next week for contact sports; football, basketball, lacrosse, field hockey and soccer will be covered under these guidelines
 - Playgrounds will be able to open on June 10th, Responsible Restart Ohio has established intensive cleaning guidelines for playgrounds to reopen
 - Discussions were held, it was decided to not open Wildwood Playground until the end of June with best practice guidelines to be posted upon reopening
 - McPeek Lodge will reopen on June 15th allowing one day rentals only
 - When the office reopens it will be a soft opening with 50% staffing the first two weeks, scheduled appointments, no walk-ins will be permitted.
